- 1. WELCOME AND INTRODUCTIONS:
- 2. TO ELECT THE CHAIRMAN AND VICE CHAIRMAN AND NOTE THE RESIGNATION OF CLLR TOLLEY (due to time constraints).

Julia Cotton opened the meeting in the absence of a Chairman and the Vice Chairman. Cllr Wendy Tolley had to resign as Chairman due to time constraints and in the absence of Toby Kinnaird, the Vice Chairman, Mark Parvin was unanimously elected to stand as Vice Chairman and presided over the meeting. It was unanimously **AGREED** that Toby Kinnaird be elected to Chair.

Sam Banks provided an update on the new Local Plan. The Plan period will be up to 2041. Following the consultation on spatial options HC will publish a preferred settlement hierarchy around June / July 2022.

The D&M NDP could either be prepared to be in general conformity with the adopted Core Strategy (up to 2031) with a net housing requirement of 21 houses focussed on the 3 settlements of Dormington, Mordiford and Priors Frome. The PC could do a relatively quick policy only NDP but site allocations and design codes take a lot longer. The NDP would be out of date when the new Local Plan is adopted and would be less robust if there are no site allocations and HC don't have a 5 year supply (they currently have about 7 years but this could change).

Alternatively the D&M NDP could be prepared alongside and following on from the new Local Plan. This would take longer but would provide a more robust and up to date NDP. It could be submitted or examined once the new Local Plan is at an advanced stage or adopted.

There would be uncertainty about the target housing figure and settlements which would be the focus for new housing. However the PC could still go ahead with a call for sites and technical site assessment and make decisions about the location and quantity of new housing in the NDP once there is greater certainty from the new Local Plan. The County Plan, Economic Development Strategy and Housing Strategy all should be considered as these provide a framework for the Local Plan (which is the planning document).

The timetable for the new Local Plan is:

- June / July 2022 Settlement hierarchy consultation
- Publication of Draft Plan for consultation Dec 2022 March 2023.
