Minutes of the previous meeting were accepted as a true and accurate record and signed by the Chairman.

20. To receive brief verbal reports from:

- a) Kat La Tzsar updated the meeting on the report that had been commissioned to investigate the possibility of lowering the speed limit or introducing a solid white line outside the proposed development. Unfortunately neither would be feasible which accords with Herefordshire Council's advice. WM Housing would be submitting the layout which was preferred by residents, though it is not preferred by Planning Officers. Residents were encouraged to support the layout which was chosen through the consultation process. Planning application likely to be submitted by the end of February. - b) Neil James noted that there had been 2 burglaries from non-dwellings during the last few months and several Road Traffic accidents. (Neil James was thanked and left the meeting at 8.00pm).
